- The superintendent reported that a public hearing final presentation of the 2016-2017 budget will be adopted at the May 3, 2016 board meeting.

- The superintendent noted that the OneMontville committee will be sponsoring a Green In Day on May 20, 2016, which encourages all to wear green as a display of community respect and acceptance.
- The superintendent expressed her thanks to Steve Toth, Dominic Esposito, Austin Thomsen, James Tevis and Andrea Woodring, for their help and team effort with the fire at Woodmont.
- President Kayne then thanked the superintendent for her excellent communication to the board and the community during the incident at Woodmont.

Presentations

Good News and Progress in our Schools

- Valley View Mrs. Zurwawlow and Miss Katz's first grade class have been learning all about animals for the past few months. We have studied habitats, food chains, and life cycles. The students are excited to start applying what they have learned and begin working on animal research projects. This will entail students researching a specific animal and creating a poster to present their findings. Be on the lookout for our posters hanging outside 3B next month!"
- Valley View The students' work from various grades compiled by Third Grade Teacher, Amy Falk and Art Teacher, Lauren Rittenhouse, were displayed for the Morris County's Council Education Association Mall Project. We are all so proud of our students' and teachers' hard work and dedication. The Project ran from Monday, April 11 to Sunday, April 17. Thank you to all of our teachers and students who participated and to Amy Falk and Lauren Rittenhouse for compiling the materials and setting up the display.
- Valley View On March 11, Nicholas Liao, a current senior at Montville Township High School and Co-President of the Montville Township Earth Club, created the "Earth Day Program" in collaboration with Mr. Mark Danilack. The environmental program, which was appropriately presented in honor of Earth Day, educated Valley View students in grade five through various hands-on interactive stations. The program engaged 60 students through the six stations. The stations were the following: racing to determine which team could separate recyclables from non-recyclables, cleaning rubber ducks through a simulated oil spill, planting seeds from household products, reusing recycled paper to create greeting cards, and differentiating between organic foods and GMO products. Each station was led by members of the Earth Club whom taught and guided the students through each activity.

- Valley View April brings our second round of bus drills to Valley View. All children will be participating in bus drills this month to remind them to wear their seatbelts; to follow bus rules; and to practice exiting a bus from another exit point in the event that the primary exit route is blocked.

- Valley View The Leadership Teams have been meeting to strengthen our commitment of inclusion, safety, and good citizenship for all.
