The New Jersey Open Public Meetings Law was enacted to ensure the right of the public to have advance notice and to attend the meetings of public bodies at which any business affecting their interests is discussed or acted upon. In accordance with the provisions of the act, the Montville Township Board of Education approved this meeting date. Notice of the meeting has been posted at the Montville Municipal Building, all Montville public schools, the Montville Public Library, the Montville Township Board of Education Administrative Office Building, the Montville Public School Website, and advertised in the DAILY RECORD.

The board president welcomed Dr. René Rovtar as the new superintendent of Montville Township Public Schools.

F. SUPERINTENDENT'S REPORT

The superintendent reported on the following items:

<u>Remarks</u>

- The superintendent read the following Tolerance and Acceptance statement into the record:
 - As the new superintendent, I wanted to briefly comment on some issues that arose at the end of the school year and make sure the community is aware of my commitment to support a culture of tolerance and acceptance within all of our schools. While I do not intend to address the specifics of the incidents that have occurred, when considering matters of this nature it is important to remember that perception is reality. While individuals may attach their own personal meaning to their words and actions, it is critical for all of us to be sensitive to how those messages are perceived and interpreted by others. It is those perceptions that become the true message, whether intended or not.

I want to assure the community that the District has character education programs that are designed to teach our students the six pillars of character: trustworthiness, responsibility, fairness, caring, citizenship and respect. We will continue to emphasize that students need to be tolerant and accepting of others, to be considerate of the feelings of others, to treat others with respect and to deal peacefully with anger, insults and disagreements. We have entered a partnership with the United Way to conduct a school climate and culture survey in all seven schools this fall. Students will be asked to respond on a scale of "disagree a lot" through "agree a lot" to various statements. The statements include "Students are nice to each other," "Students treat classmates with respect," "Students leave out those who are different," "Students pick on other students," "Students resolve conflicts without fighting, using insults, or threats," "Students are bullied," "Students in my school know what to do if they see someone being bullied," and additional questions on other topics related to their experience in school. Staff members will also provide their responses to these statements. With regard to bullying, the surveys at all three levels ask the students to indicate where the bullying is taking place, such as on the bus, on the playground or in school, as well as the nature of the bullying, such as teasing or name calling or cyberbullying. Since the students will be completing the surveys individually and anonymously, we have a high level of confidence that they will feel comfortable sharing their true feelings and impressions. The survey responses collected from students and staff will generate a wealth of data that will be provided to school level teams who will analyze the information and develop action plans to address any areas of concern.

Montville is a high performing school district. Each meeting we include on our agenda a long list of the awards and accomplishments achieved by our students and faculty. It is important to me, as the leader of the district, that we are not perceived as a district where bias and discrimination have any place in our culture. I want to ensure that we are known as a caring educational community where all can feel comfortable and accepted regardless of race, color, religion, ancestry, national origin, gender, sexual orientation, gender identity and expression, or a mental, physical or sensory disability, or by any other distinguishing characteristic. The Board's policy on Harassment, Intimidation and Bullying states very clearly that "A safe and civil environment in school is necessary for students to learn and achieve high academic standards. Harassment, intimidation, or bullying, like other disruptive or violent behaviors, is conduct that disrupts both a student's ability to learn and a school's ability to educate its students in a safe and disciplined environment. Since students learn by example, school administrators, faculty, staff and volunteers should be commended for demonstrating appropriate behavior, treating others with civility and respect, and refusing to tolerate harassment, intimidation, or bullying."

I recently found a quote by John Hume, who was awarded the Nobel Peace Prize in 1998 for his efforts to end the conflict in Northern Ireland, that speaks to the issue of diversity with succinct clarity: "Difference is of the essence of humanity. Difference is an accident of birth and it should therefore never be the source of hatred or conflict. The answer to difference is to respect it. Therein lies a most fundamental principle of peace: respect for diversity."

Maya Angelou said, "It is time for parents to teach young people early on that in diversity there is beauty and there is strength."

These quotes call to mind the critical role that parents have as their child's "first teachers." To that end, I respectfully request that parents and guardians become our partners and assist us in this very important aspect of a child's education. The Board of Education and I are

committed to working with parents and the community at large with regard to activities and initiatives that would comprise a strong joint effort to allow us to move forward in a positive spirit to ensure that all of the members of the Montville Township community can co-exist in a culture of acceptance and respect.

Public Participation – Superintendent's Tolerance and Acceptance Statement

Ten members of the public spoke regarding this topic.

- The board president thanked everyone in attendance for coming out to the meeting this evening and for their comments. She stated her hope that the healing can begin tonight and indicated the Board's willingness to work collaboratively to address these concerns.
- The board vice president and Member Palma thanked the public for their comments and indicated that there had been many good ideas and thoughts presented. The district is interested in engaging in meaningful conversations on this topic.

The board president recessed the meeting for twenty-five (25) minutes at 8:25 p.m.

- Lazar On Friday, June 5, the 8th grade mentors from the Mrs. Rapport's Leadership Program set up a field day for the middle school Life Skills class. The following Mentors organized a variety of activities for the students to participate: CJ Arena, Lexi Cocchio, Derek Gilmore, Arianne Greveson, Angelina Hahn, Skyler Herman, Jillian Howar, Alex Khalaf, Miranda Morrone, Gabriela Risteski, Samantha Shalongo, Amanda Simon, Aaron Warsaw, Matt Caprio, and Adelyne Ehntholt. As the mentors were facilitating the field day program, teachers and paraprofessionals were supervising and assisting with activities, snacks, and safety. We were fortunate that Amber Racioppi's family was able to donate the Kona Ice truck for the students and staff to enjoy on a hot day.
- Lazar 6th Grade Language Arts teacher, Suezette Given was awarded a scholarship to attend the Artist Teacher Institute co-sponsored by the New Jersey State Council on the Arts and Arts Horizons. The New Jersey Artist/Teacher Institute immerses classroom teachers, educators and artists in hands-on workshops in the performing, visual, literary and digital arts led by master

- teaching artists. ATI participants discover new pathways to creative teaching and learning in and through the arts while igniting their artistry and connecting with a community of peers. Mrs. Given will be attending an intensive summer session, *Poetry: Advancing the Poem*, at Stockton University.
- Lazar On Friday, June 6th, Lazar Middle School hosted the Hearts for the Arts benefit concert to support the Fine, Practical, and Performing Arts Department. The 2-hour concert featured performances by the Lazar flute choir, vocal soloists, jazz ensemble and a teacher band called Fridays @ 4 featuring a student horn section and backup singers. Teachers performing were drummer Jon Huppert, rhythm guitarist Peggy Travers, and bass guitarist Kenny Travers, and lead guitarist Jerry Wayne, keyboardist Chelsea DiDiego. Other student contributions included a screen show backing the concert, video recording of the show, homemade chocolate and snacks all sold by Student Council. K.13 PSE&G Settlement Funds Appropriation: 2014-2015

WHEREAS, the Montville Township Board of Education executed a negotiated settlement agreement, (the "Agreement") with PSE&G dated December 21, 2011, for payment of costs associated with the mitigation of construction impacts caused by the 500 kV Susquehanna-Roseland Transmission System Upgrade Project, (the "Project") at a total amount not to exceed \$1,500,000.00; and

WHEREAS, per the Agreement, PSE&G deposited the sum of \$1,500,000 into an escrow account on March 13, 2014, for the purpose of paying costs to the Montville Township Board of Education associated with its mitigation of the Projects construction impacts.

WHEREAS, on May 12, 2014, the superintendent of schools drafted correspondence informing district parents that the Project had been completed and that out of potential concerns for our children, that the playing fields behind the Lazar Middle School have been closed for use by Lazar students, district athletic teams and the Township Recreation Department.

THEREFORE BE IT RESOLVED, that the Montville Township Board of Education, in accordance with the provisions stipulated in the aforementioned Agreement, post-approves the appropriation of funds up to \$1,500,000.00 into the 2014-2015 school district budget for costs associated with EMF testing and the construction of synthetic turf athletic playing fields.

K.14 Authorization to Purchase Utilizing Ed-Data and State Contract Vendors: 2014-2015
