Good News and Progress in our Schools

- Cedar Hill For the past six years, the Music Education Program at Montclair State University
 has collaborated with elementary schools in a highly successful field project: Friends of
 Music Teachers in Training. The project pairs music education students with elementary
 general music specialists. Cedar Hill School will host two students from the John J. Cali
 School of Music, who will be mentored by Mrs. Joyce Janowicz.
- Cedar Hill The 5th grade Character Education Team have had their first meeting of the year and planned the agenda. They voted on continuing to help our Ghanaian student, Super Zach (one of our CH teacher's nephews) and celebrate our Veterans. The Committee decided to help with Blessing Bags for the Poor and an orphanage in South America that our School Counsellor's sister-in-law (who lost her battle with cancer) was supporting. Plickers allows the teacher to scan the classroom with a smartphone while students hold up a unique answer card. The app allows for live feedback and graphs responses on the smartboard. The kids love it. It is a great tool for instant assessment and review.
- William Mason Ms. Ronayne's PK-2nd grade class is excited about celebrating Grandparents! We have been reading stories about grandparents, and making gifts for our Grandparent's Day visit! Grandparents will come and visit us in our classroom on September 26th and we are so excited to share our day with our grandparents!
- William Mason Mrs. Stella's 3rd graders are excited to have time to use the Chromebooks in class. We have started using Raz-kids to practice reading and writing stories and we are loving it!
- Valley View The Valley View Newscast is now live! Check out our first show on the Valley View School website. Each marking period, Web Master, Len Saunders, in collaboration with teachers and students will highlight an educational topic with the community. This marking period's topic is Health and Fitness!
- Valley View The NJPTA President "The Essential Piece" Award recognizes the Valley View PTA as initiating a program/activity that speaks on behalf of all children. The success of this program/activity should build relationships with the PTA, the school staff and the community; involving families of all backgrounds; and create leadership opportunities for children and families. It can also include opportunities that children were able to get up and speak at a meeting or event. New Jersey's PTA recognized our TREP\$ program as a program that meets all of these criteria. We are so proud of our past and present EnTREPreneurs! Our SECOND Award is "The Arts At Its Finest Award". It recognizes a Local Unit that promotes the visual and performing arts by providing quality arts education programs and projects in their schools and communities, and also works with their schools and districts to promote the arts in its schools.
