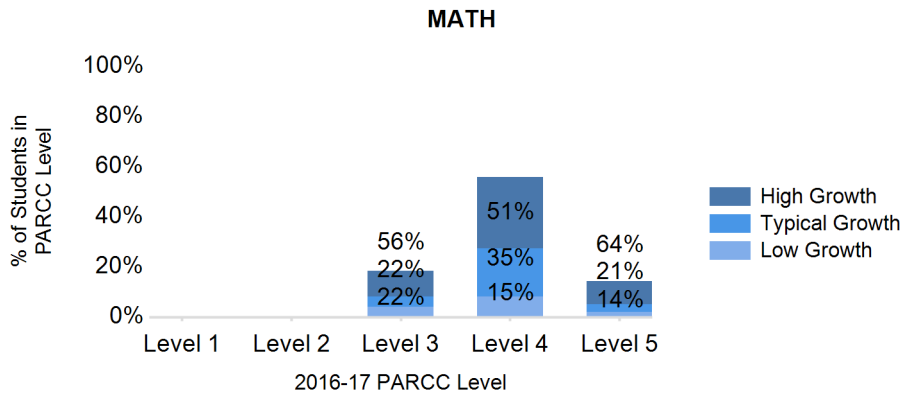
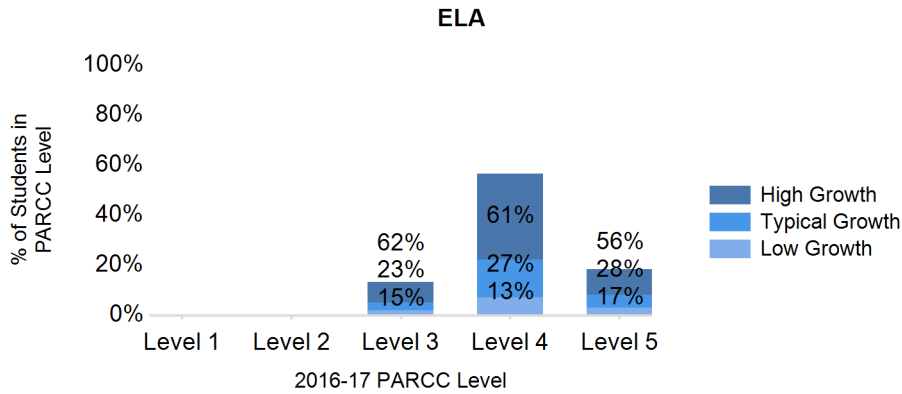

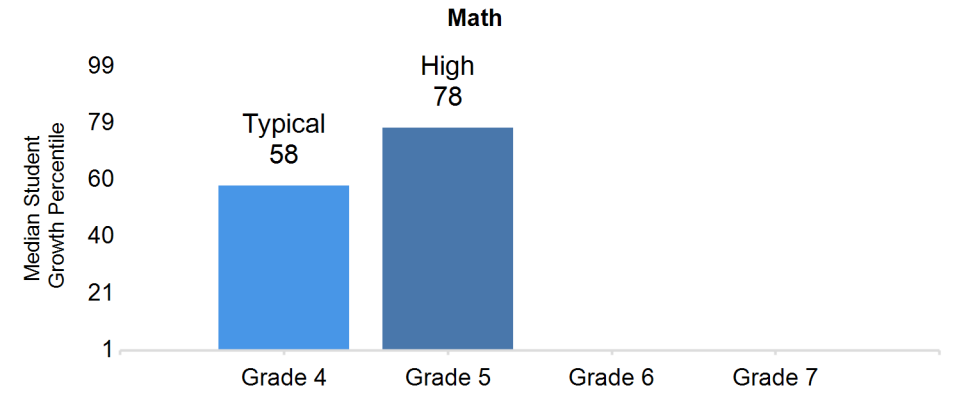
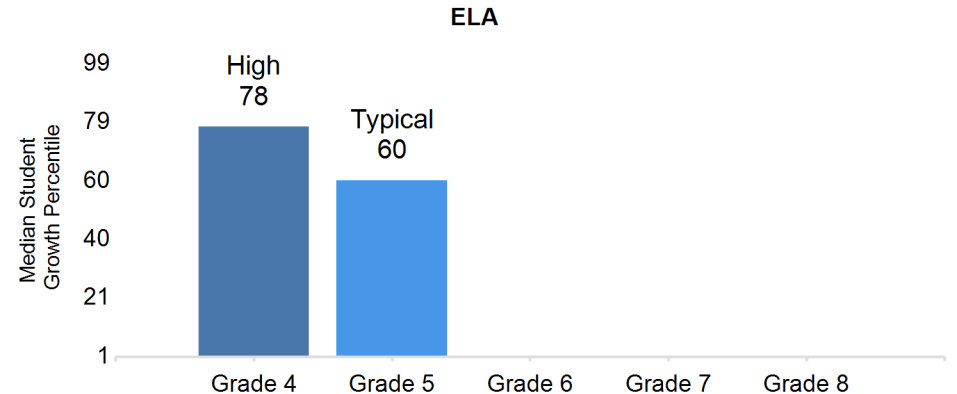
**Student Growth by Performance Level**

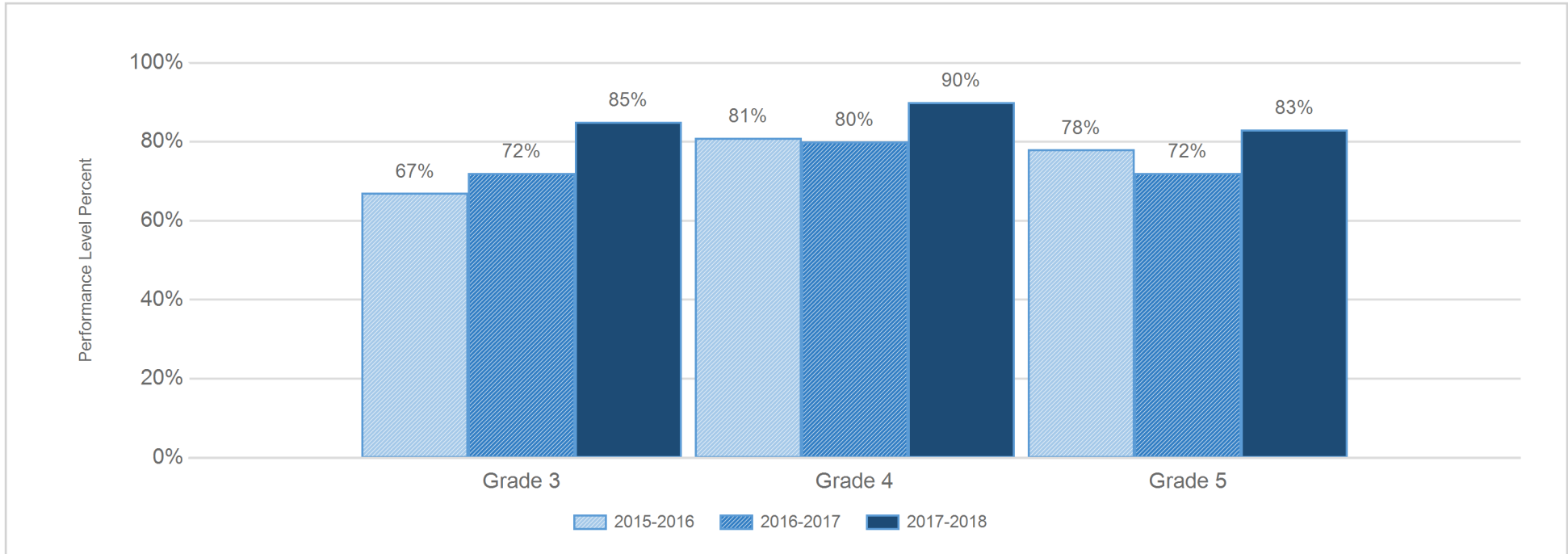

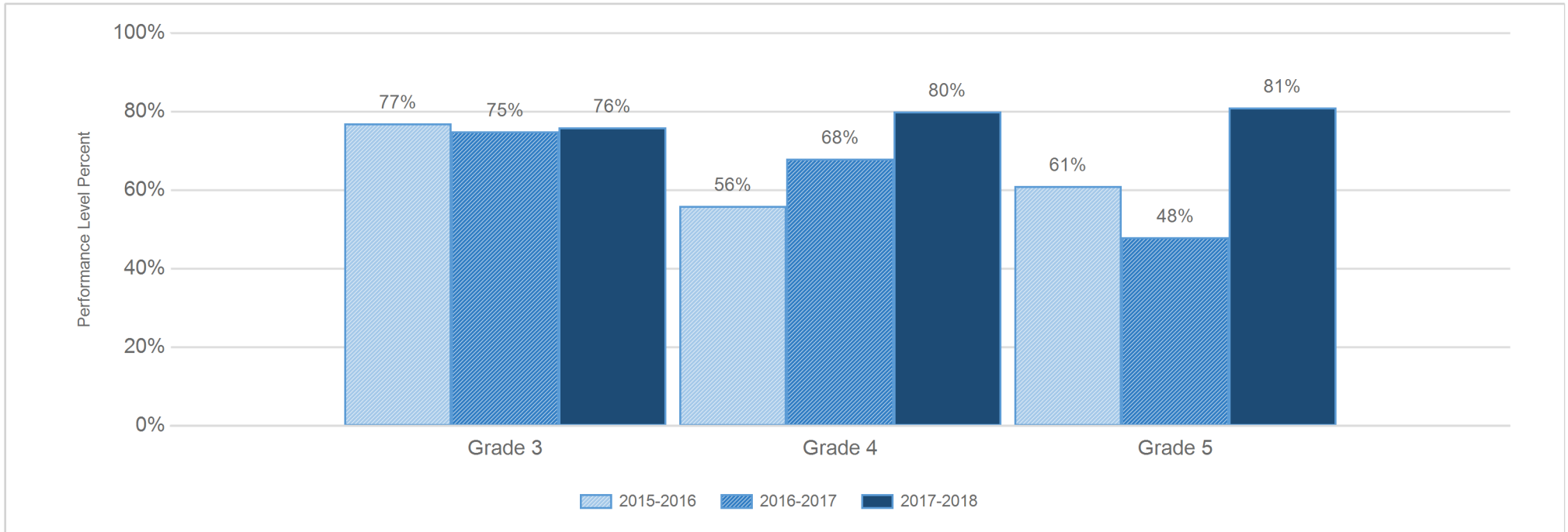

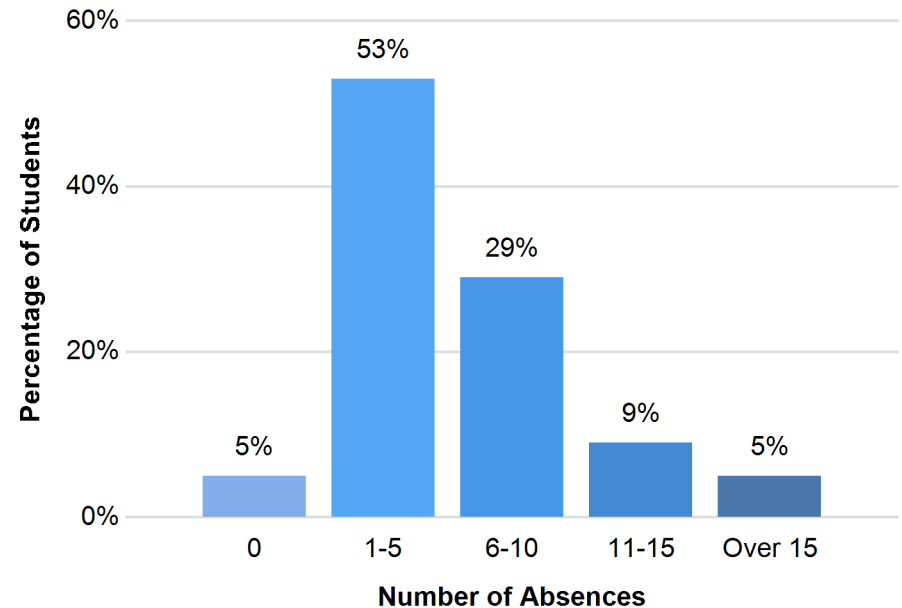

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





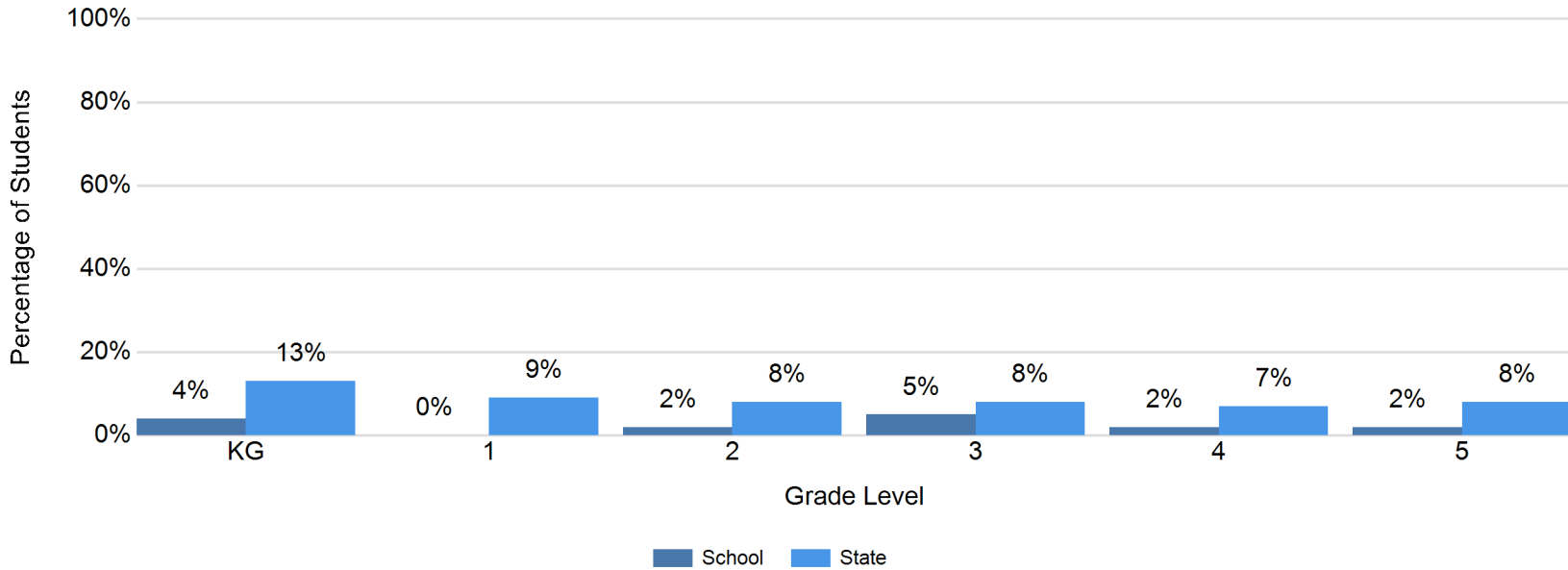

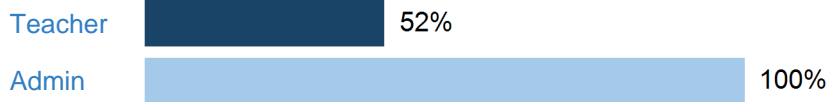

The successful utilization of cooperative learning strategies, a literature based reading program, Lucy Calkins writing units of study and learning centers provide an exciting educational environment. Teachers construct lessons that promote analytical, problem-solving skills, writing across the content areas, and learning how to apply the scientific method when conducting experiments. A guided math model drives instruction. Faculty challenge students at their level of understanding and promote best practices to drive students upwards. Students integrate technology via Google Chromebooks and IPADS to improve research skills and learning. Students participate in video streaming, web quests, document sharing via Google drive, and faculty employs SMART Boards as part of daily practice.
