Good News & Progress in Our Schools:

- Cedar Hill - Mr. DiLascio & Ms. Swiatek in 3rd Grade is utilizing a grant from Reflex Math to enhance their students' learning experience in learning their basic facts!
- Cedar Hill - celebrated Week of Respect with themed days, school counseling lessons and an assembly with Officer McGowan.
- Valley View - On September 27th, the Valley View 5th graders participated in a program called "Exercise US" in celebration of National Childhood Obesity Awareness Month. Students in the US exercised for 10 continuous hours. Valley View kicked off the event exercising from 8 am to 8:15 am. At 8:15 am, they were done with their portion of the event, but new schools started their 15 minutes exercise session from 8:15 am to 8:30 am. The pattern continued for 10 hours until schools on the west coast finished up

the event. This was Valley View's 10th year participating in the event, under the direction of Mr. Len Saunders, the school's PE teacher.

- Valley View - The kindergarten children at Valley View are very excited to start their journey of reading with our new Schoolwide reading program. They have been enjoying listening to our mentor texts, such as *Wild About Books*, and learning how to become a great reader. Recently, they were making their very own book selections and finding books of interest to them. We have also been busy learning math with our new EnVision program. The children are learning how to be super problem solvers as they begin each math lesson with our Solve and Share part. Additionally, they have been using counters and rolling dice to make themselves number experts. We look forward to continued learning and growth in the month of October.
- Valley View - October is chock full of activities at Valley View School. The Week of Respect was celebrated the first week in October. Activities included morning announcements, classroom guidance lessons and teacher led conversations on what it means to be respectful. Students created posters for the lunchroom to encourage respectful behavior during lunch. 4th and 5th grade classrooms watched a video reviewing the district's HIB policies and consequences for students who violate HIB laws.
- Valley View - Anti-Violence in Schools Week begins the third week in October to bring awareness to foster a safe, bully free, and caring learning environment for all.
- Valley View - Red Ribbon Week will kick off the fourth week in October with classroom guidance lessons, morning announcements, and teacher led conversations on making healthy choices now and in the future. The annual Red Ribbon poster contest will also take place to motivate students to choose a life path that promotes healthy decision-making.
- Valley View - The L.E.A.D. program is underway with lessons being led by Officer Scott McGowan for Valley View's three 5th grade classrooms.
- Valley View - Mindfulness Committee will be meeting this month to plan fun activities and morning announcements that will center around creating coping and resiliency skills for all in the Montville community. Student led groups will be presenting at the Mindfulness meeting as well.
- Valley View - Autumn bus and van evacuation drills are on-going this month for all students.
- Hilldale - During the week of October 1-5, all staff and students participate in a "Week of Respect." Character Education was delivered to each classroom and focused heavily on Respect, Kindness and Compassion for others. Staff and students also participated in different theme days during the week such as, "No Drama Pajama Day" and wearing blue for Bullying Prevention Day.
- William Mason - The students in Ms. Portnoff's First Grade class are starting each morning with Mindfulness. We are learning how to set an intention for the day, work on expressing our emotions and learning about perseverance, empathy and gratitude. One of our favorite activities is Mindful Movement where we practice some yoga poses like tree pose and triangle pose. Another favorite is a relaxation activity called "Melting" where we freeze up our muscles and then melt onto the ground. It is helping us practice self-control, stretch and practice self-control. We are looking forward to more mindfulness activities throughout the year.
- Lazar - Lazar Student Council elected their executive board on 9/24/18. Our President: Elijah Dor, Vice President: Olivia Barragan, Treasurer: Ryan Sun, Corresponding Secretary: Mia Grillo & Recording Secretary: Lindsay Probst.
- Lazar - On Back to School Night at Lazar, the Student Council had its first fundraiser of the year to help offset costs for future projects this year. Thank you to all the parents, staff and students that supported us!
- Lazar - Lazar "Kicked Off" our First Fun Fridays on October 5th with Football/Futbol Friday. It was a huge success! Students and staff wore their favorite team jerseys and participated in football trivia during lunch.
- Lazar - October is a month of awareness. Kicked it off on October 1st with the Week of Respect. During this week, students identified what is unique about themselves and shared it on leaves that were hung on a tree in the cafeteria. The rest of the month, will be observing School Violence Awareness week and Red Ribbon week. During those weeks, will be having their annual Camfel Assembly, and will be doing Conflict Resolution in the PE and Health classes. Students will also be writing kind messages around the building, having Officer McGowan speak to the students, and kicking off advisory. Lastly, games will be played during lunches to raise awareness of the harms of drugs and alcohol. During this time, staff will take the time to speak to students about these issues.
- Lazar – Congratulations to Lazar teacher, Karin Wardell, for having one of her paintings accepted at the Speakeasy Art Gallery in Boonton, The show is called "Oddities" and will be displayed all of October.
- Lazar - The 2nd annual 6th Grade Color War was a huge success! The White, Green, and Yellow teams were announced and hung throughout the hallways prior to the event and everyone got ready to wear their colors and came to school on Friday, October 5th, filled with spirit. Competitions included fun games such as the sponge relay, the ping pong ball carry, tug of war, beach ball carry, steal the thunder, double ball soccer and kickball. The excitement for the day was palpable and the voices of our 6th graders could be heard for miles! A fabulous day was had by all!
- Lazar - On Tuesday, October 9th, Lazar held their annual Camfel Assembly. The assembly featured: **"IT'S MY LIFE"**, a thought-provoking three-screen school assembly program that focuses on the desire for control; our quest for independence; respect; and the power to choose what we feel is best for our lives. Students learned that the power to choose requires a heavy dose of personal responsibility, and that making the responsible choice isn't always the easy choice.

Public Participation (For items on the agenda only)

Section H

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest.

In order to permit the fair and orderly expression of such comments, the Board shall set aside a portion of Board meeting, the length of the portion to be determined by the Board, for public comment on any school district issue that a member of the public feels may be of concern to the residents of the school district.

Public participation shall be governed by the following rules.

1. A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, municipality of residence, and group affiliation, if applicable;
2. Each statement made by a participant shall be limited to five minutes' duration;
3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard;
4. All statement, questions or inquires shall be directed to the presiding officer and any questions or inquires directed by a participants to another Board member shall be redirected to the presiding officer who shall determine if such statement, question, or inquiry shall be addressed by the presiding officer on behalf of the Board or by the individual Board member;
5. The presiding officer may:
 - Interrupt, warn, and/ or terminate a participant's statement, question or inquiry when it is too lengthy;
 - Interrupt and/or warn a participant when the statement, question or inquiry is abusive, obscene or may be defamatory;
 - Request any person to leave the meeting when that person does not observe reasonable decorum;
 - Request the assistance of law enforcement officers in the removal of a disorderly person when that person prevents or disrupts a meeting with an act that obstructs or interferes with a meeting;
 - Call for a recess or an adjournment to another time when the lack of public decorum interferes with the orderly conduct of the meeting; and
 - Waive these rules when necessary for the protection of privacy or to maintain an orderly operation of the Board Meeting.
