Good News & Progress in Our Schools:

- MTHS -Congratulations to Rohan Shah (Class of '20), Mihir Paranjape (Class of '20), and Aditya Sharma (Class of '20) for their participation in a prestigious summer economics program. Each student attended the "Economics for Leaders" program (Rohan and Mihir attended the program at Cornell University while Aditya attended the one offered at Brown University), conducted by the Foundation for Teaching Economics. The program was a weeklong, residential opportunity offered to 40 high school students from around the country so they could gain a better

understanding of how to integrate economics into the process of decision-making in a hands-on, experiential environment. The entire MTHS Community is very proud of Rohan, Mihir, and Aditya, and looks forward to their future contributions in the field of economics.

- MTHS – Congratulations to the MTHS Marching Band for their 1st Place finish at the US Bands State Competition in Glassboro, NJ October 27th – October 28th. The band scored the 2nd highest out of 11 other schools competing from the Group II – A size classification. In addition, the band received caption awards for “Best Visual Effect” and “Best Overall Effect.” The entire MTHS Community is extremely proud of our Marching Band, and wishes them continued success this season.
- Valley View - On Tuesday, October 9th, the Valley View Kindergarten classes participated in a health lesson from Atlantic Healthy Schools titled “Germ Busters”. Students attended a 30 minute interactive classroom presentation about germs and why it is important for them to wash their hands. The classes have been talking about good hygiene and ways to stay healthy. This is a fun health lesson which will promote healthy living. Thank you Atlantic Health Systems for visiting with our students!
- Valley View - Friday, October 19th, Fireman A.J. came to Valley View to talk to Miss Profeta’s, Mrs. Warfield’s, and Mrs. Golini’s classes about fire safety. The students came up with many questions to ask the fireman before he came. The students loved talking to about fire safety with the fireman. We all got chief badges and some of our friends got to try on fireman gear. We had a wonderful time and we thank Fireman A.J. for coming to talk to us!
- Valley View - October is chock full of school-wide events. In October, Valley View celebrated The Week of Respect, Anti-Violence Week in Schools, and Red Ribbon Week. Red Ribbon Week is underway, students are writing morning announcements, and classroom conversations are ongoing on the need to make healthy choices now for a bright future.
- Valley View - Students received grade appropriate books along with pencils, bracelets, and stickers highlighting the important messages of Red Ribbon Week.
- Valley View - Fall bus and van evacuation drills are completed. All children participated in the drills. A sincere thank you goes out to the drivers, paraprofessionals, and classroom aides for assisting. A second set of drills will be done in the spring.
- Valley View - The student leadership and character education committee members met with representatives from YEA and the United Way to review the student, staff and family surveys conducted this past June. Now, our student leaders will “turnkey” the results to other students and staff to continue to have a bully free positive-learning environment.
- Valley View - Is hitting the ice, well not exactly. Mr. Spector is organizing a night out for Valley View families to watch the NJ Devils take on the Winnipeg Jets on Saturday, December 1st at the Prudential Center.
- Hilldale - During the week of October 22-26 all students and staff celebrated “Red Ribbon Week” at Hilldale. Character Education was taught in each classroom with a primary focus on being healthy, making good choices and peer pressure. Each day was also a different theme for staff and students to participate in such as “Give Drugs the Boot” where everyone wore their favorite western attire. Goodies were also given out to students to help promote these very important messages.
- Hilldale - Many students from Hilldale Elementary school have been volunteering their time during inside recess to color cheerful drawings. These drawings have been sent to a non-profit organization Color-A-Smile which sends out these drawings to spread cheer. The recipients are troops overseas, nursing home facilities, children hospitals and any family who is in need of a smile! Hilldale students are demonstrating civic and stewardship volunteering which is an amazing thing! Keep up the great work Hilldale!

By selling glowsticks and glow bracelets that students could wear when trick-or-treating at night, Student Council raised \$268 for the MTFAS. Hilldale is hopeful that their donation will bring the first aid squad closer to their goal of purchasing a new ambulance. When the MTFAS does get their ambulance, Hilldale Elementary School will have their name displayed on the side!
- William Mason - The second grade teachers, Chris Auten, Cortney Stephenson and Gena Wallenburg, are continuing with leading students in deep breathing growth mindset exercises. We have added additional daily positive growth mindset affirmations while they deep breathe. They are: I can always improve, mistakes help me learn, I can learn anything that I want to, I like to challenge myself, My effort and attitude make all the difference, I am inspired by people who succeed, I persevere when I am frustrated. Each day we focus on a different affirmation. We also had students choose one affirmation that most resonates with them and commit to following it throughout the month of October. They wrote their affirmation in a speech bubble next to a cartoon character of themselves they created and it is posted on our hallway bulletin board.
- William Mason - Accepted the challenge of helping to find a cure for blood cancers! We joined over 27,000 schools across the country to make a difference and raise as much money as we could. Over the past 3 weeks, our students worked relentlessly fundraising online as well as collecting coins and raised a total of **\$3347**. All the money we raised will help fund further research. In medicine, research means the careful study of a disease with the goal of finding a cure. Your donations helped fund research in 7 different countries! Congratulation Students Heroes!
- William Mason - Gracie, the “famous” therapy dog, visited Mr. Wheeler and Mrs. Barberio's 3rd grade class. The students learned how Gracie helps people. They got to pet her and had the opportunity to ask her handler questions.

- William Mason - The Kindergarten students in Ms. Oberlin's class have been learning about fire safety. During fire prevention week, they read several books and poems about firefighter and how to stay safe if there should be a fire. We read a funny book called "Stop, Drop and Roll by Margery Cuyler. It was about a girl who forgot those three words! After reading the book, we wrote the words and out them in order on a paper. Then we made it into a "roll" to remember the saying. Next, we practiced how to "stop, drop, and roll" if our clothes ever caught on fire. After reading "Dot the Fire Dog" by Lisa Desimini, we made dalmatian fire dog hats. We glued some of the safety rules to our new hat. The best part of all was when the Montville Fire Department came to our school in their big firetruck! They did a terrific job (as usual) explaining about their job and the fire safety rules. They were very proud of us for knowing so many of the rules. They gave us all firehats and string bags with a pencil, ruler and eraser inside. Lastly, we all went outside and took a picture in front of the truck with our hero firefighters!

- Lazar – PERCC (Pride, Empathy, Respect, Cooperation and Citizenship) Student of the Month recipients: **October** – Hari Singampalli, Matthew Hahn, GraceMarie Williams, Aaron Parisi, George Georges.
- Lazar - On Friday, October 19th, the Art, Nutrition, Family and Consumer Studies Department at Robert Lazar Middle School hosted their annual “Bus Drivers Breakfast”. Students were responsible for scheduling, menu planning, pricing, room décor, food preparation, and service. Morning highlights involved presentations by the students to include an “Alphabet of Gratitude”, a breakfast buffet offering a wonderful assortment of student prepared foods, an international sampling table, and handmade favors. Public Participation (For items on the agenda only)

Section H

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest.

In order to permit the fair and orderly expression of such comments, the Board shall set aside a portion of Board meeting, the length of the portion to be determined by the Board, for public comment on any school district issue that a member of the public feels may be of concern to the residents of the school district.

Public participation shall be governed by the following rules.

1. A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, municipality of residence, and group affiliation, if applicable;
2. Each statement made by a participant shall be limited to five minutes' duration;
3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard;
4. All statement, questions or inquires shall be directed to the presiding officer and any questions or inquires directed by a participants to another Board member shall be redirected to the presiding officer who shall determine if such statement, question, or inquiry shall be addressed by the presiding officer on behalf of the Board or by the individual Board member;
5. The presiding officer may:

- Interrupt, warn, and/ or terminate a participant’s statement, question or inquiry when it is too lengthy;
- Interrupt and/or warn a participant when the statement, question or inquiry is abusive, obscene or may be defamatory;
- Request any person to leave the meeting when that person does not observe reasonable decorum;
- Request the assistance of law enforcement officers in the removal of a disorderly person when that person prevents or disrupts a meeting with an act that obstructs or interferes with a meeting;
- Call for a recess or an adjournment to another time when the lack of public decorum interferes with the orderly conduct of the meeting; and
- Waive these rules when necessary for the protection of privacy or to maintain an orderly operation of the Board Meeting.
